

Dermatology and Aesthetic Nurses Association Ireland Terms and Conditions

On becoming a member of DANAI you are automatically agreeing to these terms and conditions and providing us with the appropriate consent to handle your personal information in accordance with the Data Protection Act.

1.0 GENERAL TERMS

- 1.1 By registering and joining the Dermatology and Aesthetic Nurses Association Ireland you agree to be bound by the DANAI Code of Conduct and always hold Public Liability and Malpractice insurance whilst in membership and practicing.
- 1.2 Membership is for a term of 12 months. The membership Year runs from 1st April each year to 31st March the following year.
- 1.3 We reserve the right to increase the price of the membership subscription on an annual basis. You will be informed of any fee increase within your renewal e-mail.
- 1.4 Credit Card Payment. If you are not using your own credit/debit card to pay for the membership subscription, you must ask the permission of the card holder before entering the payment details. When you apply to subscribe to DANAI you are confirming that you have obtained the express prior permission of the credit/debit card holder.
- 1.5 Your membership renewals and reminders will be sent by email, as this method is faster and more environmentally friendly. An electronic Certificate of Membership is issued upon payment.
- 1.6 At the point of renewal of your membership, your renewal payment is confirmation of the continued acceptance of this contract. You may not transfer any of your rights and obligations under these terms and conditions to another person.
- 1.7 Use of the DANAI logo must only be used in reference to individual practitioners, not to use for clinic marketing.
- 1.8 Member passwords and access codes to password protected areas of the website and other associated membership benefits, are strictly for the use of the individuals to which they were issued, and must not be shared with any third party or unauthorised person.
- 1.9 Registered members must provide their NMBI PIN number to DANAI.
- 1.10 Members must inform the association of any changes in their circumstance or contact details.
- 1.11 You will also grant permission for your membership records to be held on computer for the purposes of handling membership and mailing out membership material.

- 1.13 If you are accepted into membership, but it subsequently turns out that any or all of the information provided by you was misleading or false, we reserve the right to revoke the membership with immediate effect, without the right of appeal.

2.0 REFUNDS POLICY

2.1 Since Dermatology and Aesthetic Nurses Association Ireland is offering membership and events we do not issue refunds once payment is accomplished and in the case of membership, the membership has been activated. As a customer you are responsible for understanding this upon purchasing your membership or registration for an event being held by the DANAI.

However, we realize that exceptional circumstance can take place, therefore we do honour requests for a refund on the following basis:

Non-delivery of the product: You have received no contact with the DANAI (this does not include technical problems beyond the DANAI's control).

Unforeseen circumstances: This does not include your decision to stop practising as an aesthetic nurse.

Events - Members may be invited to events organised by the DANAI, to enable members to gain information and make the best use of networking opportunities. Cancellations made 21 days or more before any chargeable event will be refunded in full. Cancellations after that date will be charged in full, although substitute attendees can be made at any time.

- 2.2 If you feel you have a justifiable reason for a refund, we will respond to any complaint or query received within five working days. This may be an acknowledgement that we have received a complaint whilst further investigations are carried out.
- 2.3 Requests for a refund will be considered by the Dermatology and Aesthetic Nurses Association Ireland within the period of 1 week after registration. You should accompany this request with detailed and grounded reasons why you apply for a refund. Please make sure your request does not contradict our Terms and Conditions. A refund is issued to you upon receipt of a Waiver of Copyright signed by you.
- 2.4 If you have any queries, comments or complaints about your subscription please contact our office we are ready to assist you and deliver professional support in a realistic timely manner.

3.0 MEMBERSHIP TERMINATION

Membership of the DANAI will cease if:

- 3.1 a member's renewal fees remain unpaid by renewal date
- 3.2 a members name is suspended or removed from the NMBI
